Eligibility Criteria

- Served in WWII or in Korea during the Korean War as a member of any of the following: the Canadian Forces, an allied force, the Merchant Navy or the Ferry Command;
- Served for a minimum of three years in the Canadian Regular Forces (may still be serving);
- Served for a minimum of three years of actual paid duty (1095 days) in the Canadian Reserve Forces or has been awarded the Canadian Decoration (CD);
- Served in NATO operations or as a member of a United Nations peacekeeping force as a member of any of the following: the Canadian Regular or Reserve Forces, the Royal Canadian Mounted Police, another Canadian Police Force, or an allied force;
- Served in Vietnam War in the forces of the United States or its allies during the war and who was a Canadian Citizen at the time of such service.
- A widow of a Veteran.

- Permit holders must be a resident of Quinte West.
- This permit is valid until December 31, 2013.
- The use of any assigned parking lot shall be at the permit holder's risk.
- The City of Quinte West shall not be responsible for personal injuries or liability for loss resulting from fire, theft, or damage to any vehicle or article left therein.
- Only one permit shall be issued.
- Parking permits shall be clearly displayed at all times.
- Any vehicle that is parked with an **expired permit, an improperly displayed permit, or no permit displayed will be ticketed.**
- A permit is only effective for the location, space, or assignment stipulated.
- The City of Quinte West or the applicant reserves the right to cancel the permit with 30 days notice.
- **The permit holder shall not reassign the parking permit to any other person without the proper written consent from the City of Quinte West.**
