



CITY OF QUINTE WEST 2018 ELECTION NOTICE OF NOMINATION FOR OFFICE

Every person who proposes to be a candidate in the 2018 Municipal Election must file a Nomination Form. Municipal Council Nomination forms must be endorsed by at least 25 persons on the prescribed form. Forms may be filed at the City Clerk's Office, City of Quinte West, 7 Creswell Drive, Trenton, during regular office hours until end of business day on July 26, 2018 and on Nomination Day, Friday July 27, 2018 between 9 a.m. and 2 p.m. for candidates for the following offices, to serve during the term of December 1, 2018 to November 14, 2022:

CITY OF QUINTE WEST MUNICIPAL COUNCIL

- MAYOR: 1 TO BE ELECTED AT LARGE
- COUNCILLOR: 5 to be elected from Ward 1 (Trenton Ward)
4 to be elected from Ward 2 (Sidney Ward)
2 to be elected from Ward 3 (Murray Ward)
1 to be elected from Ward 4 (Frankford Ward)

Nominations for the office of **SCHOOL TRUSTEE** may be filed with the designated City Clerk's Office for:

- HASTINGS AND PRINCE EDWARD DISTRICT SCHOOL BOARD
2 TRUSTEES TO BE ELECTED (*nominations to be filed with the Clerk of the City of Quinte West*)
1 to be elected from the combined areas of Ward 1 (Trenton Ward) and CFB Trenton
1 to be elected from the combined areas of Ward 2 (Sidney Ward excluding CFB Trenton) and Ward 4 (Frankford Ward)
- ALGONQUIN AND LAKESHORE CATHOLIC DISTRICT SCHOOL BOARD
1 TRUSTEE TO BE ELECTED (*nominations to be filed with the Clerk of the City of Quinte West*)
from the combined areas of Ward 1 (Trenton Ward), Ward 2 (Sidney Ward) and Ward 4 (Frankford Ward)
- KAWARTHA PINE RIDGE DISTRICT SCHOOL BOARD (English Public)
1 TRUSTEE TO BE ELECTED (*nominations to be filed with the Clerk of the Municipality of Brighton*)
from the combined areas of the Municipality of Brighton, City of Quinte West – Ward 3 (Murray Ward) and the Township of Cramahe

Nominations for all offices shall be made on the prescribed form and shall be accompanied by the prescribed nomination filing fee of \$200.00 for the Office of Mayor and \$100.00 for all other offices (*cash, certified cheque or money order*). The nomination form must be signed by the candidate, and may be filed in person or by an agent as set forth in section 33 of the *Municipal Elections Act*.
